The Chairman Cllr. John Jowers welcomed all to the meeting; following the Full ERP <u>Action By</u> Partnership meeting of the morning.

The following were reported as updates/ matters arising from those minutes:

Outstanding action from those minutes regarding John Yates (Chairman East of England Rural Forum - EERF)

 To offer a formal invitation to John Yates, Chair of the East of England Rural Forum KM SR (EERF) to next/future ERP full partnership and Steering group Meeting.

The Steering Group discussed various relevant issues which could be raised with John Yates and proposed the following questions:

- Energy Efficiency
- EERF Interface and interaction between National, Regional and County Level.
- EERF Linkages with the Regional and County political structure
- Thoughts on the future of the Regional Assembly
- · Hopes and fears regarding the future of the EERF

SR advised that further questions could be sent to her via email from the Steering Group as she was due to meet with John Yates shortly (18th January 2008).

EEDA -to facilitate the forging of better working relationship with EEDA

The Group felt that it was important to rebuild and improve a better working relationship with EEDA and to encourage their attendance at future ERP meetings.

The Group identified the need to make contact and invite Barbara Follet MP to Essex to help her get a true picture of the issues affecting communities in Essex; providing an overview of the diversity and complexity of the County and its relationship with the East of England region.

2 RSCP (Rural Social and Community Programme Update

SR advised the meeting that the RSCP funding would definitely be ceasing with effective 31st March 2008 and that this would mean the end of the 7 current projects run by EALC and RCCE. Initial discussions were being held with ECC to look at alternative replacement funding for these projects.

PR Advised that the National Association of Local Councils would also be losing DEFRA monies and the DCLG was also withdrawing funding. Government felt that money raised from precept should be used instead for this type of project.

JJ reported that there was great pressure on County Council to adopt and take up mainstream projects when government funding ceased.

NS felt that the current £230,000 RSCP funding had been used effectively and it would be a great shame to lose these RSCP projects when they currently met action points of the Essex Rural Strategy Action Plan and LAA actions.

- PW and JJ to discuss RSCP Projects alternative funding streams and the use of tapering.

3 IiC Business Plan Update

SR advised the Steering group that unfortunately due to extensive cuts to the liC budgets announced recently, it was predicted that a postponement or shelving of some liC funded projects would occur such as:

- Market Towns Initiative
- Rural Retail Advisor.
