

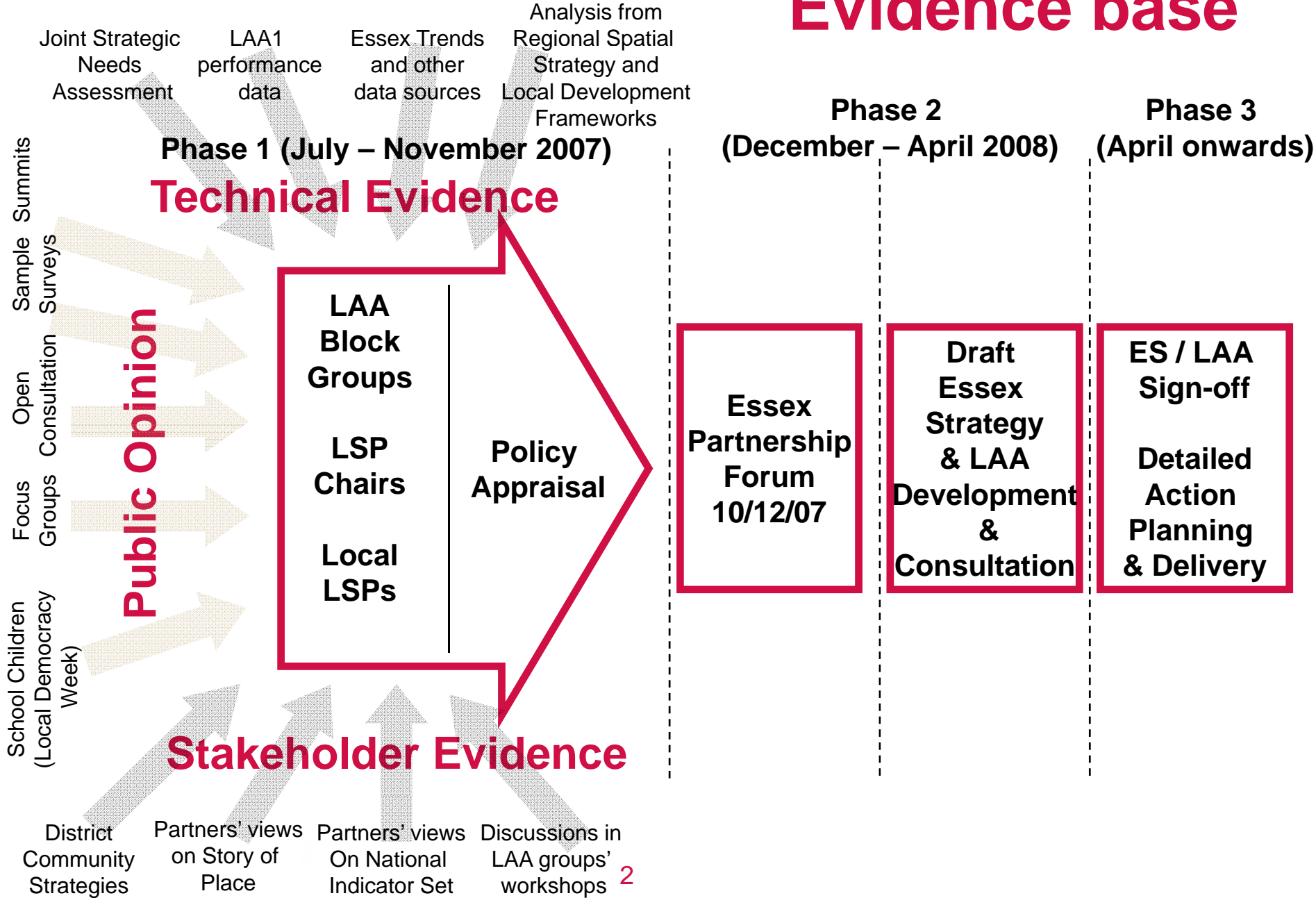

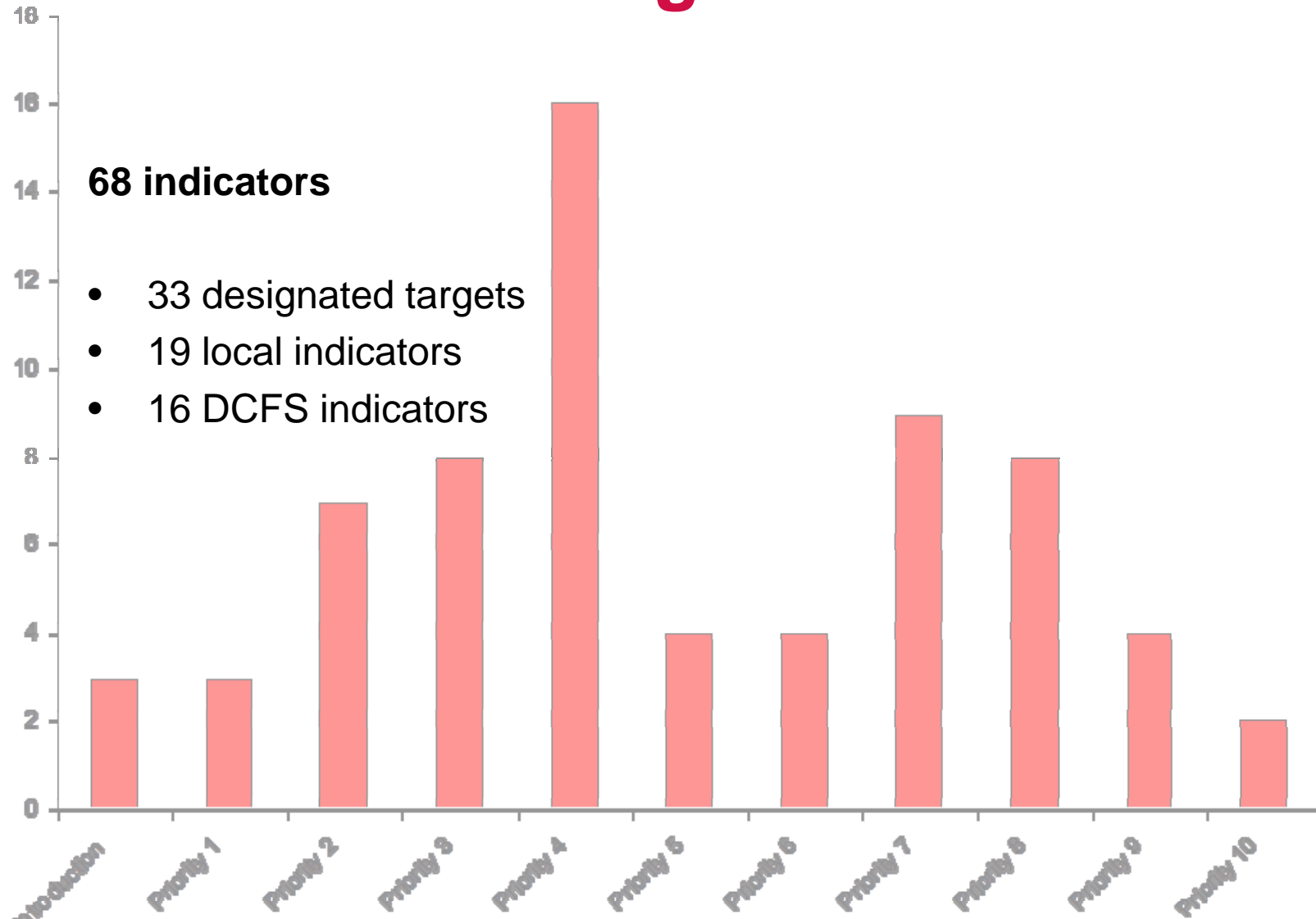
Evidence base



Priorities

1. Fewer children and young people missing education or not in education, employment or training
2. More people supported to live independently in their own homes with better support for carers
3. Better public health and longer lives
4. Children and young people realise their potential in education
5. Essex roads are safer, less congested and everyone has access to essential services
6. More participation in sport, culture and volunteering
7. Essex is a safe place to live
8. Essex has a strong and competitive economy
9. A smaller carbon footprint with less waste
10. A well managed environment

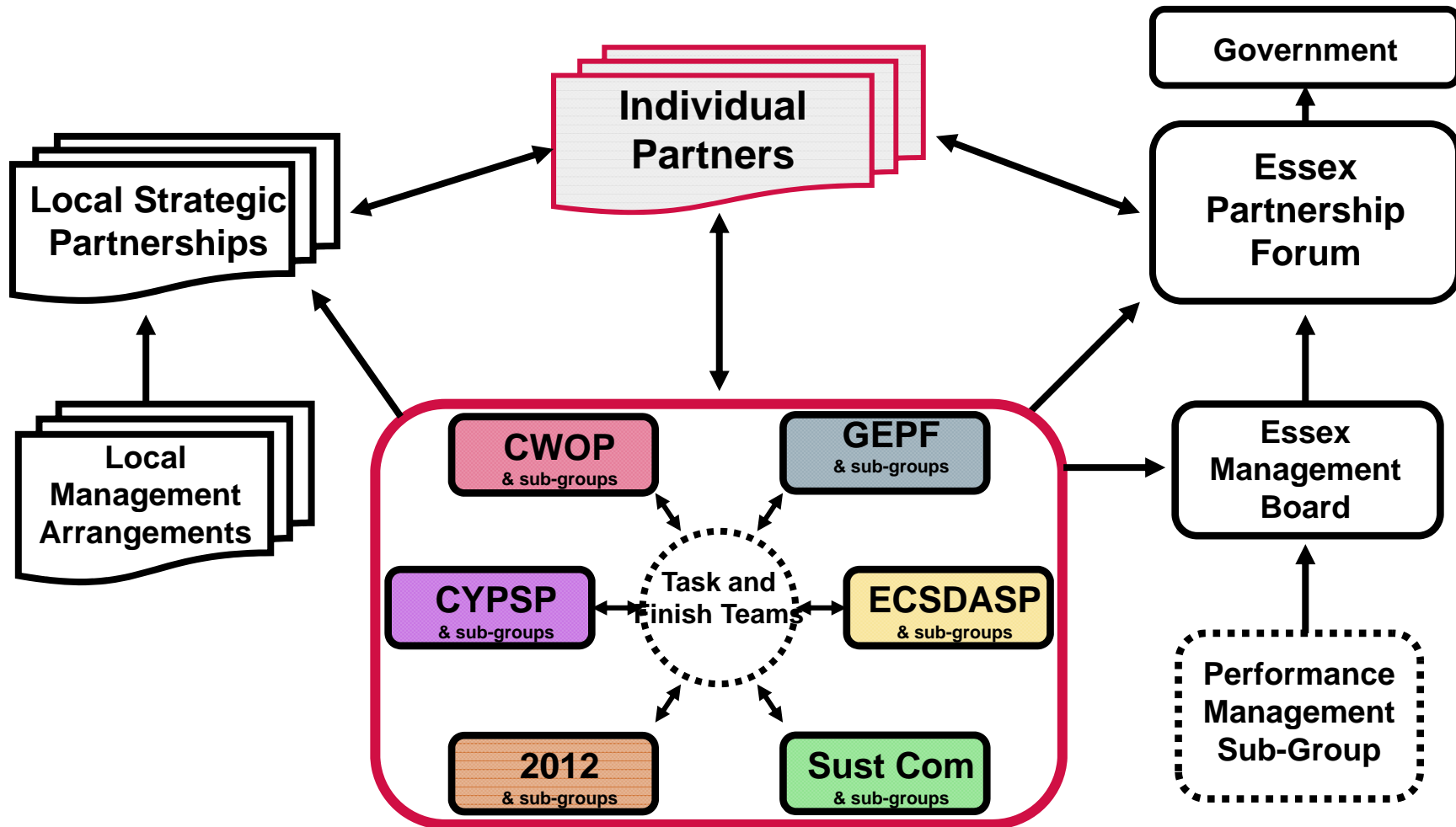
Indicators & Targets

Purpose & Aims

- Coordinate activities between sub-groups and with other Thematic Partnerships to avoid duplication, share best practice and engage widespread buy-in from all partners
- Understand and maximise the Partnership's influence, providing an Essex voice for issues around sustainable communities
- Ensure effective and appropriate communications within the partnership and for the Partnership's results to be clearly visible
- Provide a performance management role to monitor progress against LAA targets and action plans
- Focus on clearly defined outcomes, with locally defined context where possible, and ensure the delivery of agreed actions
- Identify clear roles and responsibilities through clearly articulated terms of reference

Activities

- Focus on crosscutting activities that impact on more than one area / sub-group e.g.
 - Coordinated actions to deal with climate change impacts & CO₂ reduction
 - Living landscapes and biodiversity (planning / rural)
Waste (environment / planning)
 - Education and persuasion – changing perceptions / attitudes / behaviours
 - Access to services e.g. community hubs etc.
 - Improving existing housing stock given market downturn re. new builds
 - Children travelling to schools
 - Households living in temporary accommodation

Next Steps

- **June – August**
 - Development of District LAAs & Action Plans and Thematic Partnership Action Plans
 - Rural / Neighbourhood Proofing – stage 2
- **Early September**
 - Deadline for receipt of all Action Plans by Essex Partnership Secretariat
 - Joint meeting
- **17th October**
 - Special EMB project selection meeting
- **28th November**
 - Essex Partnership Forum & final approval of action plans and allocation of PRG

- Analyse data re. disaggregation using CLG rural / urban classification
- Analyse baseline data used in LAA to explore urban / rural difference
 - Levels - District (all) / Rural & Urban (14)/ Ward (5)
